

**2015 IN ACAC Dolphin Invitational
Anderson, Indiana
July 10-12, 2015**

- SANCTION:** This meet is being sanctioned by USA and Indiana Swimming.
Sanction Number IN15329 .
- HOST:** Anderson Community Aquatics Club (ACAC), Dolphin Club Swim Team
(summer affiliate of ACAC).
- LOCATION:** East Side Dolphin Club
3003 Lindberg Road
Anderson, IN 46012.
- FACILITY:** Dolphin Club is a 50 M pool, 9-lane course with separate diving well.
Pool depth is 5' at the start end. Colorado Timing System will be used.
04.2.2C. The competition course has not been certified in accordance with 104.2.2C(4).
Please bring your own lawn chairs for seating. Pop tents may be used for shade and placed
along the fence. Swimmers and coaches sit on the west side of the pool. Spectators sit on
the east side of the pool only. The starting block surface gets slippery, and also very hot in
extreme heat. Identical towels will be provided for each block/lane.
- ADMISSION:** \$2.00 per person, age 13 & over. Children 12 & under are free. Psych Sheets will be
available at entrance for \$6.00. Concessions will be available all day. There is room to
park RV's in the grassy area in front of the club (no connection available).
- ELIGIBILITY:** Swimmer(s) must be registered with USA Swimming prior to the competition (202.2.9 E).
Age as of July 11, 2015 shall determine the swimmer's age for the entire meet (205.2.2).
Indiana Swimming does not process on-site athlete registration.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern this meet.
202.3.2- At a sanctioned competitive event, USA Swimming athlete members must be
under the supervision of a USA Swimming member coach during warm-up, competition,
and warm-down. The Meet Director or Meet Referee shall assist the athlete in making
arrangements for such supervision. 202.2.9 D - Any swimmer entered in the meet,
unaccompanied by a USA Swimming member coach, must be certified by a USA
Swimming member coach as being proficient in performing a racing start or must start
each race from within the water. It is the responsibility of the swimmer or the swimmer's
legal guardian to ensure compliance with this requirement. ISI rule - Coaches MUST
constantly display their current USA Swimming coach credential to gain deck access. The
meet referee reserves the right to ask for coach credential display and/or deny deck
access if coach does not comply or card is no longer valid/current. ISI rule to include USA-
S 102.8.1 B - In swimming competitions, the competitor must wear only one swimsuit in
one or two pieces except as provided in USA Swimming rule 205.10.1. All swimsuits shall
be made from textile materials. For men, the swimsuit shall not extend above the navel nor
below the knees, and for women, shall not cover the neck, extend past the shoulder, nor
extend below the knee. 202.2.9 H - Use of audio or visual recording devices, including a
cell phone, is not permitted in changing areas, rest rooms or locker rooms. 202.2.9 I -
Changing into or out of swimsuits other than in locker rooms or other designated areas is
prohibited.
- FORMAT:** This meet will be Timed Finals.
- ENTRY INFORMATION:** Swimmers will be limited to 4 events per day. **ACAC reserves the right to limit the number
of heats in all events to keep the time line manageable. No ACAC swimmers will be cut
from this meet.** Meet will be considered full at 500 athletes. Teams not accepted will be
notified by Tuesday, July 1 at noon. We will use "fly-over" starts for all events. **Please use
long course (LCM) seed times.** Hy-Tek Team Manager e-mailed entries are the preferred
method of entry. Any club submitting entries on paper must pay a \$50.00 data input fee.

ENTRY DEADLINE: Entries will be accepted starting Monday, **June 15th**. Entry deadline will be **Monday, June 29th**. Deadline will be extended if the meet is not full. **However**, event changes, updates, and/or deck entries **will not be accepted at the meet**. **We will accept time updates through Monday, July 6th by noon**.

ENTRY FEES: \$4.00 per individual event plus \$2.00 Indiana Swimming surcharge.

AWARDS: ACAC "Dolphin" Team trophies will be awarded to the top three scoring teams. Individual "High Point" Dolphin trophies will be awarded in each age group & gender. Points awarded in Open or 10 & U events will be added to the high point total of respective age group. Scored age groups will be 8 & U, 9-10, 11-12, 13-14, 15 & O. **Please note all 9-10 and 8 & U swimmer points will be calculated from Saturday and Sunday events only**. Medals awarded from 1st through 3rd and ribbons awarded for 4th through 9th. Awards will be given to coaches of each team after the meet. We will not mail awards unless a SASE mailer is provided.

SCORING: 1st = 22, 2nd = 19, 3rd = 18, 4th = 17, 5th = 16, 6th = 15, 7th = 14, 8th = 13, 9th = 12, 10th = 10, 11th = 8, 12th = 7, 13th = 6, 14th = 5, 15th = 4, 16th = 3, 17th = 2, 18th = 1

CLERK OF COURSE: No clerk of course. Please have all your swimmers report directly to the starting blocks.

DIRECTIONS: If coming from Indianapolis, take I-69 North to exit 26 (IN-9, 109, Scatterfield Road) and turn left onto IN-9/109/Scatterfield Road. Take Scatterfield Rd. to Lindberg Rd. You will be on Scatterfield Road approximately 5 miles. Turn right onto Lindberg Rd. Dolphin Club will be on the right, approximately ¼ mile down the road. If coming from Fort Wayne, take I-69 South to exit 34. Turn right onto IN-32. Take IN-32 to Rangeline Road. (You will be on IN-32 approximately 4 miles) Turn right onto Rangeline Road. At the 4-way stop, turn left onto Lindberg Road. Dolphin Club will be on the left, less than an 1/8 mile down the road.
